

## StarHub Enterprise Lion Dance Giveaway (“Lucky Draw”)

1. This Lucky Draw commences on 1 December 2024 to 12 January 2025, both dates inclusive (“**Lucky Draw Period**”).
2. This Lucky Draw will be governed by these standard terms and conditions (“**Terms**”). By participating in this Lucky Draw, you (“**the Participant**”) confirm that you have read and understood these Terms and that you agree to be bound by and to comply with these Terms. Non-compliance with or breach of any of the Terms may disqualify you, and any prize won by you may be forfeited, withheld, withdrawn or reclaimed.

### Eligibility

3. To be eligible to participate in this Lucky Draw, you must be at least eighteen (18) years old and a StarHub Enterprise customer and not have any outstanding bills with StarHub Ltd and/or its related corporations (collectively referred to as “**we**” or “**us**” or “**StarHub**”) during the Lucky Draw, at the time of the draw and at the time of the claim or use of the Prize.
4. Employees of StarHub, each of their immediate families, as well as StarHub’s commercial customers and bulk subscription customers, are not eligible to participate in this Lucky Draw.

7. The Lucky Draw will be conducted electronically.

## **Collection**

13. If you win, you will be notified via email after the Lucky Draw Period no later than seven (7) days from the day of the draw.
14. To claim the Prize, you must confirm acceptance of your win with us via email. If we do not receive an answer from you within 24 hours after initial contact is made by us, you may be disqualified.
15. If a Winner is disqualified for any reason including due to ineligibility or failing to comply with our arrangements for the distribution of the Prize or failing to comply with any of these Terms, then other Participants will be selected instead. We shall not be liable for late, lost, misdirected or unsuccessful efforts to contact and notify a Winner, to the extent that this arises from the Winner's failure to comply with any of these Terms.

## **Personal Data**

Such personal data may include without limitation your name, telephone number, email address, personal identification or passport number, as well as your image, picture, photographs or likeness. You confirm you have read and understood and that you agree to the StarHub Personal Data Protection Policy.
